### DIRECTIONS

**FROM CMI AIRPORT TO HOTEL:** HEAD EAST ON AIRPORT ROAD. TOWARD US-45. TURN LEFT ONTO US-45. HOTEL ENTRANCE APPROXIMATELY 4 MILES ON LEFT HAND SIDE NEXT TO TGI FRIDAY'S.

**FROM ORD AIRPORT TO HOTEL:** TAKE 1-294 SOUTH TO I-80 WEST. GO 3 MILES. TAKE I-57 SOUTH 110 MILES TO I-74 EAST. TAKE I-74 EAST TO EXIT 182 NEIL STREET. TAKE A RIGHT ONTO NEIL STREET. FOLLOW FOR APPROXIMATELY 3 MILES. HOTEL IS ON RIGHT SIDE

**FROM I-74 TO HOTEL:** TAKE NEIL STREET EXIT TO THE SOUTH. GO APPROXIMATELY 4 MILES ON NEIL STREET. THE HOTEL IS JUST BEYOND THE KIRBY STREET INTERSECTION ON THE RIGHT HAND SIDE OF THE ROAD NEXT TO TGI FRIDAY'S.

**FROM HOTEL TO SITE:** HEAD NORTH ON S NEIL STREET TOWARD FLORIDA AVENUE AND MAKE RIGHT ONTO FLORIDA AVENUE. TURN RIGHT ONTO SOUTH WRIGHT STREET.

**FROM I-57 TO SITE:** TAKE THE UNIVERSITY STREET EXIT TO MATTIS STREET. TURN RIGHT ON MATTIS STREET AND FOLLOW TO KIRBY STREET. TURN LEFT ON KIRBY AND FOLLOW TO FOURTH STREET. TURN RIGHT ON FOURTH STREET. FOLLOW TO ST. MARY'S ROAD AND TURN LEFT. THE ATKINS TENNIS CENTER IS ON THE LEFT SIDE OF THE ROAD APPROXIMATELY 1/8TH MILE.

**FROM I-74 TO SITE:** TAKE THE NEIL STREET EXIT TO THE SOUTH. FOLLOW NEIL STREET TO ST. MARY'S ROAD. TURN LEFT ONTO ST. MARY'S ROAD. FOLLOW ST. MARY'S ROAD APPROX. 1/2 MILE AND THE ATKINS TENNIS CENTER IS ON THE LEFT SIDE OF THE ROAD.
